Information: The size of an individual particle of attapulgit is chronic less than 5 µm. IARC has classified attapulgit dust (fibers <5µm) as Class 3 ("Can not be classified for carcinogenicity in humans")

This product may contain quartz (crystalline silica). In 1997, the IARC ruled that the inhaled portion of crystalline silica could cause lung cancer in humans.

However, not all types of crystalline silica and all industrial practices can be associated with this state of affairs (IARC Monographs Vol.68)

In June 2003, the EU Scientific Committee on Occupational Exposure Limits (SCOEL) reported that the consequence for humans of inhaling crystalline silica dust was silicosis. "We have enough information to determine that the relative risk of lung cancer is higher in people with silicosis. Thus, avoiding the development of silicosis will reduce the risk of cancer ... "(CSLEP SUM Doc 94-final, July 2003)
